## Information regarding Question 18.4 on the GRA application - Confirmation of LPI Qualifications:

As the local PI you must obtain your Chief/Chair of department signature in Authorization Signatures Section 18; Q 18.4 of the GRA application. Note <u>you cannot sign on your own behalf</u>; you jeopardize your submission being returned if you sign in the Section. For clarification, we are providing the following example using the Department of Medicine:

- If you are affiliated with McMaster University in the Department of Medicine you will require sign off from the Chair, Dr. Mark Crowther <u>crowthrm@mcmaster.ca</u>
- If you are affiliated with the Hamilton Health Sciences Department of Medicine you require sign off from the Chief, Dr. Khalid Azzam <a href="mailto:azzamk@hhsc.ca">azzamk@hhsc.ca</a>
- If you are affiliated with St. Joseph's Healthcare Hamilton in the Department of Medicine you require sign off from the Chief, Dr. Madeleine Verhovsek <u>verhovm@mcmaster.ca</u>
